

Terms & Conditions: Photo License

Thank you for agreeing to allow Trulia (operated by Trulia, LLC, which is a part of Zillow Group, Inc.) to use one or more of your images (the "Images"). These terms and conditions (the "Terms") set forth the terms that govern the provision of Images to Trulia by you. By consenting to allow Trulia to use the Images, you agree to be subject to these Terms.

1. You own and are the original author of the Images. You hereby grant to Trulia a perpetual, worldwide, non-exclusive, royalty-free, transferable, irrevocable worldwide license to reproduce, publicly display, publicly perform, sublicense, distribute and otherwise use the Images on any part of Trulia's website or social media channels.
2. Trulia will use commercially reasonable efforts to include your social media handle each time your Images are used.
3. To the fullest extent permitted by applicable law, you hereby irrevocably waive and release Trulia and its affiliates from any claims or demands arising in connection with Trulia's use of the Images, including without limitation claims for defamation and invasion of privacy or relating to rights of publicity, regardless of the context in which the Images may be used. YOU UNDERSTAND THAT THESE TERMS INCLUDES A RELEASE OF ALL KNOWN AND UNKNOWN CLAIMS. In giving this release, which includes claims which may be unknown at present, you acknowledge that you have read and understand Section 1542 of the California Civil Code which reads as follows: "A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if known by him must have materially affected his settlement with the debtor." You hereby expressly waive and relinquish all rights and benefits under that section and any law of any jurisdiction of similar effect with respect to the release of any unknown or unsuspected claims you may have against Trulia, its employees, officers, directors, and agents.

You represent and warrant that you are legally entitled to grant the above license and other rights granted above and that by licensing the Images to Trulia or granting such other rights, you are not violating any law, breaching any contract, or infringing upon the rights of any person or entity. You represent and warrant that: (a) the Images are your original work of authorship and (b) the Images do not incorporate and are not derived from any third-party materials. If your employer has rights to intellectual property that you create, you represent and warrant that you have received permission to license the Images on behalf of that employer, or that your employer has waived such rights for the Images.
5. You understand that the decision by Trulia to use or include the Images on Trulia's website or social media channels is entirely that of Trulia. Trulia may remove or reuse the Images at any time.
6. **Limitation of Liability.** NEITHER PARTY WILL BE LIABLE FOR ANY LOSS OF USE, INTERRUPTION OF BUSINESS, LOST PROFITS, OR ANY INDIRECT, SPECIAL, INCIDENTAL, OR CONSEQUENTIAL DAMAGES OF ANY KIND REGARDLESS OF THE FORM OF ACTION, EVEN IF IT HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

These Terms contain the entire understanding of the parties relating to its subject matter and supersedes all prior representations, negotiation, writing and agreements with respect to the subject matter hereof. If any provision of these Terms is held be to invalid or unenforceable for any reason, the remaining provisions will continue in full force and effect. These Terms shall be governed by the laws of the State of Washington and the United States without regard to conflicts of laws provisions thereof. Trulia may assign the license set forth in these Terms to a successor in interest to all of substantially all of its assets, business or stock without your prior consent.
